TRADE TRANSPORT DISTRIBUTE

1. Introduction

- 1.1 You may access most areas of our site www.petredec.com ("Website") without registering your details with us. Certain areas of the Website may only be available to you if you register with us.
- 1.2 By accessing any part of the Website, you shall be deemed to have accepted these Terms of Use in full. If you do not accept these Terms of Use in full, you must leave the Website immediately.

2. Licence

- 2.1 You are permitted to print and download extracts from the Website for your own individual use on the following basis:
 1. no documents or related graphics on the Website are modified in any way;
 2. no graphics on the Website are used separately from the corresponding text; and
 3. Petredec's copyright and trade mark notices and this permission notice appear in all copies.
- 2.2 In particular, but without limitation, you must not use any part of the materials on the Website for commercial purposes without obtaining a licence to do so from us and/or our licensors.
- 2.3 Unless otherwise stated, the copyright and other intellectual property rights in all material on the Website (including without limitation photographs and graphical images) are owned by Petredec or its licensors. For the purposes of these Terms of Use, any use of extracts from

- 4.3 You are prohibited from posting or transmitting to or from the Website any material:

 2. for which you have not obtained all necessary licences and/or approvals; or

4. which is technically harmful (including, without limitation, computer viruses, logic bombs, Trojan horses, worms, harmful components, corrupted data or other malicious software or harmful data).

4.4 You may not misuse the Website (including, without limitation, by hacking);

4.5 Petredec shall fully co-operate with any law enforcement authorities or court order requesting or directing Petredec to disclose the identity or locate anyone posting any material in breach of clause 4.2 or clause 4.3.
